**\*Rosters:** Teams must have a roster submitted before the drawing. Managers have until the first game to make adjustments.

**\*Men and Women Team players** must be **LATINO**; (defined as one of the parents being of Latino heritage) with the exception of **3 NON-LATINOS** listed on their rosters. Teams competing with illegal players will be **disqualified** from the tournament. **Managers must check in at the registration table prior to the first game in order to receive bracelets for token players.** It is the manager's responsibility to provide proper identification upon request. A valid Driver's License **AND** Birth Certificate are required to settle a protest. Protests involving illegal players must be filed **prior** to the start of a game. **\*Co-Ed Team players: Anyone can sign up and participate, OPEN!**

**\*Tournament cash payouts:** will be prorated and based on 24 men's teams & 12 women's teams & 12 co-ed teams. *Por La Gente Association reserves the right to change the format based on the number of teams entered.*
